Participating in a mission team is a privilege and requires a significant amount of responsibility. Please read through the following, signing your initials on every line and your full signature at the bottom indicating your willingness to comply with these expectations.

_____ I will make note of trip payment deadlines and make every effort to turn in funds prior to deadlines. I understand that I will be removed from the team if deadlines are missed.

_____ I will attend all scheduled team meetings or let the team leader know ahead of time if I must miss. I understand that attendance for at least 80% of team training meetings is required to stay on the team.

_____ I understand that any financial contributions toward this trip, whether paid by me or another person, are nonrefundable per IRS and Milestone Church guidelines. If I am unable to go on this mission trip because of missing fundraising deadlines, not attending required number of meetings, or any other personal reason, the money paid toward the trip is not refundable.

_____ As a team member, I will pay careful attention to and observe the behavioral, spiritual, and safety guidelines given to me by my team leaders.

_____ I understand that I am not to pursue any romantic interest, develop any specific relationship, or be physical in any way with a person of the opposite sex unless they are my spouse during this trip.

_____ I understand that I am going to serve and not be served. I will do what is asked of me with a willing heart.

_____ I will not complain or state the obvious about uncomfortable conditions on the trip. I will let a team leader know if I am not feeling well.

_____ I will follow the dress code of the team and avoid the use of tobacco, alcohol or illegal drugs while on this trip.

_____ I will refrain from negative political comments regarding our own country or our host country. I will be sensitive to the practices, food, and living situation of the culture we are serving.

_____ I understand that I may be sent home at my own expense if I am unable or unwilling to meet these conditions.
